Nakon vijećanja zatvorenog za javnost, održanog 17. januara 2019.

Donosi slijedeću presudu, koja je usvojena istoga dana:

## POSTUPAK

1. Ovaj slučaj temelji se na aplikacijama podnesenim Sudu protiv Bosne i Hercegovine u skladu sa članom 34. Konvencije za zaštitu ljudskih prava i temeljnih sloboda (“Konvencija”) na različite datume navedene u tabeli koja se nalazi u dodatku.

2. Aplikante je zastupala gđa H. Kapetan, advokat iz Travnika.

3. Vlada Bosne i Hercegovine je obaviještena o ovim aplikacijama (“Vlada”).

## ČINJENICE

4. Lista aplikantata i relevantni podaci o aplikacijama navedeni su u tabeli koja se nalazi u dodatku.

5. Aplikanti su se žalili zbog neizvršavanja ili kašnjenja u izvršenju domaćih odluka.

## PRAVO

### I. SPAJANJE APLIKACIJA

6. S obzirom da se ove aplikacije odnose na sličan predmet, Sud smatra primjerenim da ih ispita zajedno u jednoj presudi.

## II. NAVODNA POVREDA ČLANA 6. stav 1. KONVENCIJE I ČLANA 1 PROTOKOLA br. 1

7. Aplikanti se žale zbog neizvršavanja ili kašnjenja u izvršenju domaćih odluka donesenih u njihovu korist. Oni se pozivaju, izričito ili u biti, na član 6. stav 1. Konvencije i na član 1 Protokola br. 1 koji glasi:

### Član 6. stav 1.

„Prilikom odlučivanja o njegovim građanskim pravima i obavezama ... svako ima pravo na ...suđenje u razumnom roku...pred ...sudom...“

### Član 1. Protokola br. 1

„Svaka fizička i pravna osoba ima pravo na neometano uživanje svoje imovine. Niko ne može biti lišen njegove imovine osim kada je to u javnom interesu i u skladu s uvjetima propisanim zakonom i općim načelima međunarodnog prava.

Prethodne odredbe, međutim, ni na koji način ne umanjuju pravo države da primijeni zakone koje smatra potrebnim kako bi regulirala korištenje imovine u skladu s općim interesom ili kako bi osigurala plaćanje poreza ili drugih doprinosa ili kazni.“

8. Sud ponovno ističe da se izvršenje presude koju je donio bilo koji sud mora smatrati sastavnim dijelom „suđenja“ u smislu člana 6. Sud se također poziva na svoju praksu u pogledu neizvršavanja ili kašnjenja u izvršenju konačnih domaćih presuda (vidi *Hornsby protiv Grčke*, br. 18357/91, tačka 40., *Izvještaji o presudama i odlukama* 1997-II).

9. U vodećim predmetima *Spahić i drugi protiv Bosne i Hercegovine*, br. 20514/15 i 15 drugih, tačke 25.-31., 14.11.2017., i *Kunić i drugi protiv Bosne i Hercegovine* br. 68955/12 i 15 drugih, tačke 26.-31., 14.11.2017., Sud je već utvrdio povredu u odnosu na pitanja slična onima u predmetnom slučaju.

10. Sud dalje napominje da je odlukama iz predmetnih aplikacija naređeno poduzimanje određene mjere. Sud stoga smatra da odluke o kojima je riječ predstavljaju „imovinu“ u smislu člana 1. Protokola br. 1.

11. Nakon što je ispitalo sve materijale koji su mu podneseni, Sud nije našao niti jednu činjenicu ili argument koji bi ga mogao uvjeriti da donese drugačiji zaključak o dopuštenosti i meritumu ovih pritužbi. Imajući u vidu svoju praksu o ovom pitanju, Sud smatra da u predmetnom slučaju vlasti nisu uložile sve potrebne napore kako bi u potpunosti i blagovremeno izvršile odluke donesene u korist aplikantata.

12. Ove pritužbe su stoga dopuštene i ukazuju na povredu člana 6. stav 1. Konvencije i člana 1. Protokola br. 1.

### III. PRIMJENA ČLANA 41. KONVENCIJE

13. Član 41. Konvencije propisuje:

„Ukoliko Sud utvrdi da je došlo do povrede Konvencije ili njenih Protokola, te ukoliko zakonodavstvo visoke ugovorne strane o kojoj je riječ omogućuje samo djelomično obeštećenje, Sud će, po potrebi, odrediti pravičnu naknadu oštećenoj strani.“

14. Imajući u vidu dokumente koje ima u svom posjedu, kao i svoju praksu (vidi, naročito, *Spahić i drugi protiv Bosne i Hercegovine*, br. 20514/15 i 15 drugih, tačke 36.-43., 14.11.2017., te *Kunić i drugi protiv Bosne i Hercegovine*, br. 68955/12 i 15 drugih, tačke 37.-46., 14.11.2017.), Sud smatra opravdanim dosuditi iznose navedene u tabeli koja se nalazi u dodatku.

15. Sud dalje napominje da odgovorna država ima obavezu izvršiti presude koje su i dalje izvršne.

16. Sud smatra primjerenim da se zatezna kamata zasniva na najnižoj kreditnoj stopi Evropske centralne banke uvećanoj za tri postotna boda.

### IZ NAVEDENIH RAZLOGA, SUD JE JEDNOGLASNO,

1. *Odlučio* spojiti ove aplikacije;
2. *Proglasio* aplikacije dopuštenima;
3. *Utvrđio* da ove aplikacije ukazuju na povredu člana 6. stav 1. Konvencije, te člana 1. Protokola br. 1 u odnosu na neizvršavanje ili kašnjenje u izvršenju domaćih odluka;
4. *Utvrđio* da tužena država mora u roku od tri mjeseca osigurati odgovarajućim sredstvima izvršenje neizvršenih domaćih odluka navedenih u tabeli koja se nalazi u dodatku;
5. *Utvrđio*
  - (a) da tužena država, u roku od tri mjeseca, ima aplikantima isplatiti iznose navedene u tabeli koja se nalazi u dodatku, pretvorene u valutu tužene države prema tečaju na dan izmirenja;
  - (b) da će se od isteka navedenog roka od tri mjeseca do izmirenja, na navedene iznose plaćati obična kamata po stopi jednakoj najnižoj kreditnoj stopi Evropske centralne banke u periodu neplaćanja, uvećanoj za tri postotna boda.
